Sub: Affiliation of new B.Ed. College in the name of Al Hera College of Education

Sir,

With reference to the subject mentioned above I am directed to inform you that the Hon'ble Vice-Chancellor of the West Bengal State University is pleased to approve the affiliation of new B.Ed. college in the name of AL HERA COLLEGE OF EDUCATION, Vill- Kodalia, P.O.- Dakshin Bagundi, North 24 parganas, Pin- 743429, from the academic session after getting the concurrence of the University Council Meeting held on 29/07/2015 subject to fulfillment of following conditions:-

1. The course fee is Rs. 75 thousand per year (seventy five thousand per year) only and the payment can be accepted only by A/C payee Cheque/ Demand Draft. No extra fee, in any form, can be taken.
2. The annual intake will be of 02 unit i.e. 100 candidates (One Hundred), out of which 80 seats for the freshers and the remaining 20 for the deputed teachers. As per N.C.T.E. Regulations 2014, full time faculty will be 16 (sixteen) including the Principal.
3. An amount of Rs. 41,000,00/- has to be paid by the college authority to the University as an inspection fee against Demand Draft in favour of " West Bengal State University " payable at "Barasat" or " Kolkata".
4. The afforesaid college will be allowed to offer following Methodss from the academic session 2015-16:
Bengali, English, Sanskrit, Arabic, Histoty, Geography, Physical Science, Life Science, Mathematics, Work Education, Education, Physical Education, Eco-civics.
5. The College has to come under Central Counselling network of the University for the purpose of admission.
6. The pay and allowances of the teachers/ faculty must follow the latest UGC, NCTE and State Government norms. The payment to the staff has to be made through A/C payee Cheque drawn on a (preferably) Nationalized Bank.
7. The Security of service of the teaching and non- teaching staff has to be ensured.
8. The Governing Body of the College has to be constituted as per the University Statute within one month from the commencement of the academic and administrative activities of the College.


